OBJECTIVES AND INVESTMENT POLICY

The Sub-Fund, expressed in Euro, aims to generate positive total returns by investing in a diversified portfolio consisting primarily of government and corporate bonds (both fixed and floating rate) issued by governments and government related issuers, corporations, other non-government issuers and located globally. The diversified portfolio may include: fixed-interest and floating rate securities, non-investment grade securities, asset backed securities ("ABS"), mortgage backed securities ("MBS"), contingent convertible securities ("CoCos"), preferred shares, currencies and cash.

The Sub-Fund may invest:

- At least 80% of its net assets in investment grade instruments;
- Up to 20% of its net assets in non-investment grade instruments;
- Up to 20% of its net assets in government bonds, corporate bonds (investment grade and non-investment grade) issued by entities located in emerging markets;
- Up to 10% of its net assets in distressed and default securities;
- Up to 10% (cumulatively) of its net assets in ABS and MBS;
- Up to 10% of its net assets in CoCos;
- Up to 10% of its net assets in preferred shares;
- Up to 10% of its net assets in units/shares of UCITS and/or other UCIs including UCITS compliant exchange traded funds ("ETF") which provide exposure to the above mentioned asset classes;

- Up to 5% of its net assets in debt securities issued by Mainland China issuers through Bond Connect program;
- Up to 35% of its net assets in money-market instruments.

The Sub-Fund may invest without limitation in instruments denominated in currencies other than the reference currency (EUR), and it may use strategies to hedge developed market currency risks, in relation to currencies different from the EURO. The non-Euro currency exposure will not exceed 40% of the Sub-Fund's net assets. The Sub-Fund may use financial derivative instruments for investment and for risk hedging purposes.

The Sub-Fund will not enter into total return swaps nor in repurchase or reverse repurchase agreements.

The Sub-Fund is suitable for investors who search medium term investments and the investor must be able to accept a certain volatility and the possibility of losing part of the invested amount.

The Sub-Fund is not managed in reference to a benchmark. The Sub-Fund is actively managed.

Share Class R is capitalization Share-Class. For Share-Class S, the net incomes of the Sub-Fund will be distributed in accordance with the Prospectus of the Fund.

You may request to redeem the shares held at any moment, by sending a request on any business day.

- **Credit risk:** The Sub-Fund invests in securities whose credit rating may get worse, increasing the risk that the issuer is unable to fulfil its commitments with a negative impact on the securities' price.
- **Developing market risk:** the Sub-Fund is exposed to securities highly sensitive to political and economic instability of developing countries such as civil conflicts, changes in government policies and in taxation, currency fluctuations and other developments in the laws and regulations of countries in which investments may be made. Price changes may be higher than those in the markets of developed countries.
- **Investing in the People's Republic of China (PRC)** is subject to the risks of investing in emerging markets and additional risks, which are specific to the PRC market. In case of investment in China A shares and in debt securities issued by Mainland China issuers, where securities are held in custody on a cross-border basis, there are specific legal/beneficial ownership risks linked to compulsory requirements of the local central securities depositories

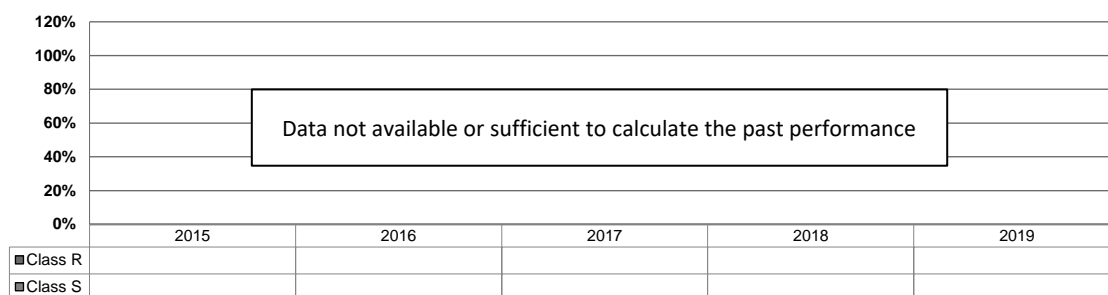
