#### **OBJECTIVES AND INVESTMENT POLICY**

The Sub-Fund, expressed in Euro, aims to obtain a positive return over the reference benchmark index by investing in: a) equities mainly issued by companies listed or traded on

stock exchanges or any regulated markets of the countries comprised in the Index;
