OBJECTIVES AND INVESTMENT POLICY

The Sub-Fund, expressed in Euro, invests all of its Net Asset Value in the units of UCITS or other UCIs that comply with legal requirements and pursue investment strategies aimed at a positive absolute return. The currency risk between the underlying investments and the Sub-fund's currency is systematically hedged ("currency hedging"). The Sub-fund may be fully invested in Cash where the Investment Manager believes that market circumstances require it, in order to protect the interests of the Unit Holders. The Sub-fund does not fall within the scope of the regulation (UE) 2017/1131 on money market funds.

The benchmark of the Sub-Fund consists of the index "1-month EURIBOR".

The Sub-fund is actively managed and the degree of freedom allowed within the management of the sub-fund is significant. The relative risk and positioning to the benchmark is monitored. To provide a disciplined management approach, risk limits are set to contain investment risk. This may impact the extent to which the composition of the portfolio and its performance deviate from that of the benchmark.

You may request to redeem the units held at any moment, by sending a request on any business day. This is a capitalisation Sub-Fund that re-invests all its revenue.


